- Per School Board Policy 2:120, Board Members are Responsible for Board Member Orientation and Development.

Open Meetings Act

**- All Board Members Are Required to Complete the Open Meetings Act
- Board Members in Office on January 1, 2012 Must Complete the Training By December 31, 2012
- Board Members Taking Office After January 1, 2012, Must Complete the Training Within 90 Days After Taking the Oath**

PDLT Mandatory Training

- Board Members Taking Office After June 13, 2011, are Required to Complete 4 Hours of Professional Development Leadership Training Within the First Year of His/Her Term

PERA Training

- Board Members must complete the Performance Evaluation Reform Act Training Prior to Voting On a Dismissal Based Upon "Optional Alternative Evaluation Dismissal Process For PERA Evaluations"
